THIS AGREEMENT, made on the date last shown by and between Pairadox Cassanova /Danielle Tursky and the undersigned Owner or Lessee of the mare described below("MARE OWNER"):

1. BREEDING:

The MARE OWNER hereby engages service by live cover from Pairadox Cassanova (the "Stallion") for the following Mare for the 2022 breeding season

NAME OF MARE, REGISTRATION NUMBER, AND BREED (the "Mare")

2. BREEDING FEE AND BOOKING FEE:

STUD FEE: \$800 after January 1 2022

The Breeding stud Fee includes a non-refundable booking fee of \$350 payable with this Agreement, which reserves in the Stallion's book for 2022 a breeding for the Mare. MARE OWNER agrees to pay the balance and any other fees due before mare is picked up.

3. MARE CARE

MARE OWNER agrees to provide hauling for mare to and from breeding barn or STALLION OWNER can pick up and drop off mare for \$1.25 a mile round trip .

Mare care boarding fee is \$20 a day fee boarding until the mare is picked up
- palpations and ultrasounds will be performed at no extra cost on site. If requesting vet services a farm call/ trailering fee of \$60 will be applied, not including any charges incurred by veterinarian that will be billed back to Mare owner.

4. CONDITION AND OWNERSHIP:

MARE OWNER represents and warrants that the Mare is in sound breeding condition and free from disease and infection. A copy of the Mare's certificate of registration reflecting the ownership of the Mare by the MARE OWNER should be submitted with this Agreement together with the completed ATTACHMENT. If the MARE OWNER is a lessee of the Mare, then MARE OWNER should be submitted with this Agreement together with the completed ATTACHMENT. If the MARE OWNER is a lessee of the Mare, then MARE OWNER should so submit a lease agreement or other document reflecting recognition of applicable breed registry of that lease.

5. LIVE FOAL GUARANTEE:

The MARE OWNER is guaranteed one "live foal," meaning a foal which stands, nurses, and lives for 24 hours. If the Mare proves barren, aborts her foal, or the foal is stillborn, a return season will be provided for the subsequent year only, upon the payment of a re-breed fee of \$350 plus cost of shipping for AI or mare care for live cover. Proper notification shall be a written certification by a licensed veterinarian within seven days that the Mare has slipped or produced a nonviable foal.

6. MULTIPLE FOALS:

The payments provided in paragraph 2 are for one foal for this breeding season for this Mare. Should more than one embryo or foal result from a breeding, MARE OWNER shall pay an additional Breeding Fee for each additional embryo or resulting foal. No breeding certificate for any foal shall issue without such additional payment.

7. SUBSTITUTION:

If the Stallion dies, or is sold, or becomes unfit for service prior to settling the Mare or the Mare dies before being settled, then this

Agreement shall terminate and the Breeding Fee (not including the Booking Fee) shall be refunded to the MARE OWNER. Another mare may be substituted only upon the express written consent of the STALLION OWNER.

8. BREEDER'S CERTIFICATE:

Upon notification of birth of live foal, full payment of all fees and expenses, and the performance of all other obligations of MARE OWNER under this Agreement, STALLION OWNER shall issue a breeder's certificate to MARE OWNER.

9. WARRANTIES and liabilities: NO WARRANTIES, EXPRESS OR IMPLIED, SHALL ACCOMPANY THE BREEDING RIGHT CREATED BY THIS AGREEMENT UNDER THE AGREEMENT. MARE OWNER ACKNOWLEDGES AND AGREES THAT STALLION OWNER IS NOT A VET AND WILL HOLD STALLION OWNER HARMLESS FOR ANY AND ALL POSSIBLE INJURIES, ACCIDENTS, OR DEATH WHILE IN THE CARE OF THE STALLION OWNER FOR BREEDING.
